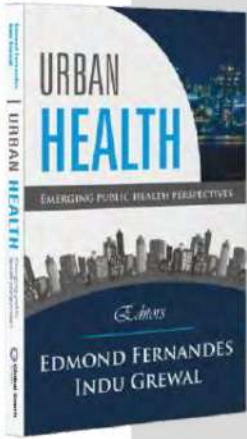

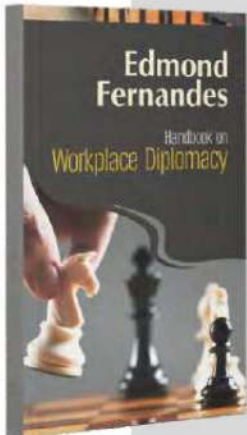

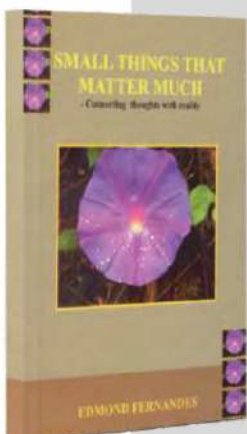

Nepal was hit by earthquake of magnitude 7.8 on Richter scale around 11:56 a.m local time on April 25, 2015 causing injuries, disabilities, deaths and structural damage.¹ The earthquake struck in central Nepal at a shallow depth of approximately 15 kilometers (km), according to the US Geological Survey. The epicenter of the earthquake was located approximately 77km northwest of Kathmandu, Nepal's capital city, and 73km east of Pokhara, another major population center. More than 20 aftershocks, ranging between magnitude 4.5 and 6.6, followed the initial earthquake.

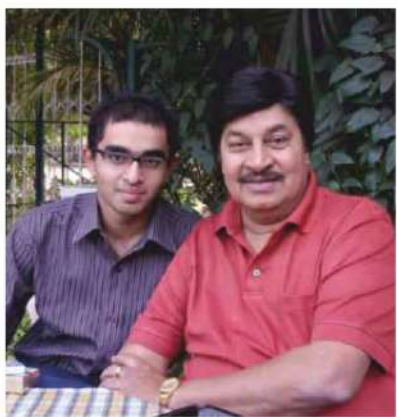

Mangalurean doctor will address UN regional meet in Thailand tomorrow

Mangaluru: A Mangalurean doctor will deliberate on how frameworks on disaster risk reduction can be strengthened by mainstreaming health in all policies across different sectors and agencies at the United Nations Economic and Social Commission for Asia and the Pacific (Escap) in Thailand on Tuesday.

Escap is the regional development arm of the United Nations for the Asia-Pacific region. It is made up of 53 member states and nine associate members, with a geographical scope that stretches from Turkey in the west to the Pacific island nation of Kiribati in the east, and from the Russian Federation in the north to New Zealand in the south.

Dr Edmond Fernandes, founder and CEO, Center for Health and Development (CHD Group) and guest faculty, department of public health, Nitte University, has been invited as the resource person to address the regional forum on translating global frameworks into practice.

Dr Edmond said Asian countries are being brought together in this dialogue on what is the way forward to optimise and translate global policies into grass-root actions.

Dr Edmond will highlight on how south-south co-operation at the ASEAN level can create a new world order in strengthening international development and achieving disaster resilience and meaningfully bringing climate change adaptation practices. Different

countries will also share their experience and how disaster response is handled and sharing of learning and best practices will take place through this Asia-level dialogue, he added.

The coherence approach is emphasised in the various global, regional and national frameworks pertaining to disaster risk reduction and the United Nations member states in Asia and the Pacific have called for enhancing regional co-operation to build resilience to disasters in the region.

Besides that Dr Edmond will hold parallel meetings with Chulalongkorn University, Mahidol University and other institutes in Thailand to further the public health agenda for Asia.

Three landmark frameworks - the Sendai Framework on Dis-

aster Risk Reduction 2015-2030, the 2030 agenda for sustainable development and the Paris agreement under the UN Framework Convention on climate change have all called upon member states to mainstream disaster resilience in the context of sustainable development.

The role of local governments in decentralizing risk informed development and adapting the global agendas to local milieu and constraints is in the process of being fully operationalized.

In this thematic session, participants will share various good practices in the region including Escap's pilot capacity building training workshop in mainstreaming disaster risk reduction into subnational development planning and budgeting processes in Central Java Province, Indonesia; UNDP's '5-10-50' programme to support countries and communities to deliver better risk-informed development; ADPC's training course of the regional consultative committee on disaster management on the mainstreaming disaster risk reduction into development; and GIZ's approach of suitability modelling as a good practice example for risk-informed spatial planning at subnational level.

Dr Edmond Fernandes to train doctors in Assam

MANGALURU: Dr Edmond Fernandes, founder and CEO, Centre for Health and Development (CHD Group) and member, Health Task Force, DDMA, Government of Karnataka, has been invited as the main resource person to train the medical doctors working in the Boat Clinics in Assam.

He will help them help upgrade their skills and competency in community medicine and public health for the Medical Officers Training Programme to be held in Guwahati on August 3 and 4.

Centre for North East Studies and Policy Research (C-NES) has been operating the Boat Clinic program in Assam with support from National Health Mission (NHM), Government of Assam since 2008. Given the nature of floods in Assam and the fury of the Brahmaputra river, boats are used by C-NES to reach difficult areas to provide healthcare to the people of Assam when none exist.

Dr Fernandes will train the medical officers on a variety of public health areas ranging from climate change and human health implications, health in humanitarian emergencies, the recent updates of the National

Health Policy 2017, sustainable development goals and the Paris agreement and how it needs to be translated into regional level implementation in the healthcare sector.

Post the training of the officers, he will hold a health camp for the people in the boat clinic in Guwahati.

C-NES is lead by Sanjoy Hazarika, founder and managing trustee, who was a former correspondent of The New York Times and a member of the first National Security Advisory Board.

This training for medical officers is being done in association with the National Health Mission, Regional Resource Centre - NE, RNTCP and CHD Group - India.

Disaster management: City doctor files PIL in Supreme Court

Mangaluru: Dr Edmond Fernandes (in pic), chief executive, Center for Health and Development (CHD-India), has filed a public interest litigation (PIL) in the Supreme Court seeking the apex court's intervention in disaster management.

The Mangalorean doctor has requested the apex court to direct the ministry of home affairs and offices of the chief ministers and principal secretaries - revenue (disaster management) to take appropriate steps to set up an advisory body at the state disaster management authority for all states across the country as per the Disaster Management Act 2005.

In the PIL filed last week, Dr Fernandes vs Union of India & others, the petitioner requests the court to order the formation of such a body involving all stakeholders like public health doctors, public health engineers, social scientists, architects, town planners and journalists so that disaster preparedness, response, relief and rehabilitation are effectively carried out with proper drills and capacity building exercises from time to time.

The petitioner has stated that he has been deeply moved by the tragic stories of loss and grief during disas-



ters as people work a lifetime to build something and nature takes it away in just few minutes. The need

to give attention to disaster management is long overdue, he adds.

The petition states that 2015 was the hottest year on record and India was among the top three countries in the world hit by disasters and having an economic loss worth \$3.30 billion. On an average, India loses \$10 billion per year due to disasters.

"The idea to achieve sustainable development goals will be an exercise in futility if we do not prepare for addressing the grave public health issue of disaster management and prevent a watershed moment for development," he says.

Disasters lead to disruption of health services, damages infrastructure, affects agriculture and creates livestock losses besides compromising on security for women, children and elderly. Rapidly proliferating climate change are compelling enough to review, strengthen and institutionalize risk reduction, multi-sectoral capacity building and emergency public health preparedness, he mentions in the PIL.

US govt selects city doctor as Legislative Fellow

Mangaluru: A Mangaluru doctor has been selected as a Legislative Fellow, a fellowship supported by the US department of state.



Dr Edmond Fernandes, founder & CEO, Centre for Health Development Group, is among the 12 persons selected for this fellowship from India. He will leave for the US in October.

The aim of this fellowship is to understand and establish networks among the mid-level professionals in the

US and India. They will be exposed to the working of the US government departments besides knowing about public policies and relevant streams related to the core nature of their work.

Dr Fernandes, adjunct faculty, dept of public health, KSHEMA, Nitte University, will seek to build and strengthen the Indo-US partnerships in terms of public health and policy domains.

In the US, he will be travelling to Washington DC, Pennsylvania and New York. Dr Fernandes will be majorly working in the city of Philadelphia, where the declaration of Independence and the Constitution was signed.

The legislative fellowship will also focus on the structure of the US government, the legislative processes, role of civil society and the impact of good governance on the lives of civilians.

He will also engage in civic leadership engagements and grass-root level activities while in the US. He will also meet the professionals and the US government officials during the Professional Fellows Congress.

As part of the fellowship's diplomatic mandates, he will host an American counterpart during their visit to India. The legislative fellowship is managed and implemented by the World Learning Inc.

This Mangaluru doc makes a difference

Where there is a calamity, this young doctor steps in with his medical team, rendering immediate relief and care for needy

Training Boat Clinic staff

Dr Fernandes was in Assam recently to conduct a three-day training for medical staff of Boat Clinics. "Once in every two years, Brahmaputra river creates new channels of flow submerging existing islands and creating new islands in the process. People abandon their crook bamboo-thatched houses and shift to another island with family and livestock in boats made from reeds. Due to the nomadic way of life, residents do not have electricity, pure water and sanitation. "The social determinants of health have not been addressed," rued Dr Fernandes. But the Boat Clinic or Akha is a ship of hope in a valley of flood. Started in 2005, there are 15 such boat clinics for islands in 13 districts, delivering health services to the doorstep of 15 lakh inhabitants.

“A doctor has to move away from his comfort zone and become a nurse, laboratory assistant, pharmacist and even counsellor. It is a one-man show. You can either save people in distress or leave them to their fate.”

AFTER completing MD (Doctor of Medicine in Community Medicine), everyone expected Edmund Fernandes to follow the traditional route of practising medicine in a hospital or private clinic. But he surprised his peers and teachers by walking the less trodden path: examining the ill that plague our public health system and finding an antidote for it.

Those close to Dr Fernandes knew that the young doctor's heart was set on redressing the larger issue of health. Barely 30, the doctor has already participated in three relief missions, including the recent Gujarat floods, as part of his mission.

"My first relief mission was in Philippines, which was destroyed by Haiyan Typhoon in 2013," recalls Dr Fernandes. The typhoon had claimed 6,300 lives. He was next involved in providing help to residents of Chennai, who were ravaged by the worst-ever floods in 2015. It was possible for the health consultant to get involved and render help post disasters as the Centre for Health and Development (CHD), which he heads, has strategic partnership with different institutions working in areas of disaster management.

A strategic partnership with New Delhi-based SEEDS had helped Dr Fernandes lead a medical team to Gujarat. "SEEDS oversees rehabilitation services in schools, with logistical help from corporates," he says. In all 307 patients attended their health camps conducted in rural pockets of Banaskantha district between August 1 and 15.

"Banaskantha, the worst-hit district, had witnessed 101 deaths. Nearly 80,000 people were displaced by floods. Even after a fortnight, the flood waters have not receded at many places. "He warned that if a cleanliness drive is not initiated at the earliest, there will soon be water-borne and vector-borne diseases.

The abject poverty in the villages, says

Dr Fernandes, has been a revelation. It's a slow road to development.

"They are at least half-a-century behind. Women are still backward. A woman attending a health camp complained of acute eye pain but refused to lift the veil and allow me to examine her eye," he said. As India enters its 71st year of Independence, the doctor says he found revolutionary schemes like RTE and others to be the privilege of a few.

Dr Fernandes wears many hats on his young head. He is founder

and Chief Executive Officer of CHD and member of Task Force, District Disaster Management Authority (DDMA). He is also involved in conducting seminars, capacity building training in areas of disaster management and global health. His CHD was behind the move to make seat belts compulsory in Mangaluru.

But does he miss conventional medical practice? No, says Dr Fernandes, explaining that practising medicine with limited resources is a bigger challenge.

Dr Fernandes has also authored two books and writes frequently on public health issues. He hopes that CHD will become an institution, changing lives and creating more jobs. He also hopes more corporates help in the rehabilitation efforts in disaster-struck areas. And what's his motto in life? The good doctor sums it up with a paraphrased line from George Eliot's poem, which he says is his guiding principle in life: "What do we live for, if not to help others."

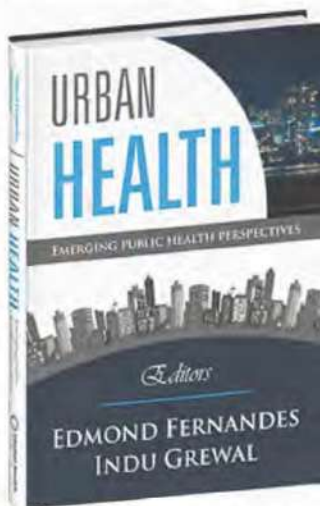

Book Review 'Urban Health - Emerging Public Health Perspectives'

Dr Edmond Fernandes and Dr. Indu Grewal - two noted public health professionals of the country have published a new book titled Urban Health - Emerging Public Health Perspectives. Through this book, the two medical doctors have collated a valuable collection of literature on urban health from various experts on an assortment of topics.

Urban Health is a nascent subject in India's public health context since the attention of the systems and governance is divided. But the book clearly illustrates that Urban health is like a ticking time bomb with paucity of policies around urban health. The book also reflects how cities are the ones affected by natural disasters, climate change and pandemics and all the sustainable progress gets washed away with zero urban health focus.

The book builds on empirical evidence of authors and their years of experience and secondary quantitative data that supports authoritative arguments into how urban futures are shaping up in the healthcare space particularly for public health. Urban Health - Emerging Public Health Perspectives



highlights roles that non government agencies and academicians including civil servants can play in building the mandate for urban health, and along with that how inter-sectoral coordination with a focus on urban health is crucial for sustainable development goals.

The contributions in the book

have borrowed examples intermittently on best practices in selected cities around the world which can be emulated by other low and middle income countries to suit their policies and geo-politics in a way that can enhance sustainable urban health planning, programmes and policy gaps.

The book however lacks uniformity in substance and style since the editors have picked the authors from diverse backgrounds. While the focus has been on urban health, some authors chose to focus on the theoretical side of urban health, while some focused on the implementation side and while some others focused on the academic side of it. This stretched the book into multiple angles which tickles imagination but remains spread out for a reader looking at only a single point focus. The book could have brought in contributions from urban planners and hospital architects which could have paved a pathway of health system infrastructure and how this could play out for coming decades in low and middle income countries and what this could mean for high income countries at large.
